Internal controls play a critical role in preventing, or cautioning, potential threats that could tarnish a corporation's image and impact its business transactions. Our experienced teams conduct independent reviews and investigate suspected problem areas, including anti-money laundering, anti-bribery, and corruption concerns relating to the U.S. FCPA and UK Bribery Act, for diverse businesses with operations in the Asia Pacific region. We help analyse policies and procedures to find gaps or breaches in existing safeguards, and are adept at designing and implementing controls that serve to diminish deficiencies. We can then monitor these controls going forward to ensure compliance with imposed sanctions.

Our technology experts are also skilled in the design and implementation of systems that protect proprietary information in both electronic and hard copy forms, including trade secrets and employee data.

Representative Assignments

- Engaged by a European multinational pharmaceutical firm to identify the source of counterfeit products found in several Southeast Asian markets. Our client was particularly concerned because the counterfeits contained no active ingredients and there were potential health risks for customers using the drug. Extensive investigative work traced the source of the counterfeit drug to Zhejiang, China. The counterfeiting operation was coordinated by a well-organised Taiwanese syndicate that had established connections throughout Southeast Asia. After sufficient evidence was gathered, we coordinated multiple raids in each jurisdiction to seize the infringing product. A raid was also conducted at a key location in Taiwan, which was coordinating the illicit activity. Computer forensics provided further evidence of the distribution network, the key players involved, and details on both quantities manufactured and the profits made from the counterfeiting activities.
- Successfully identified, in the PRC and Hong Kong, concealed assets worth US\$100 million belonging to the chairman (guarantor) of a major failed (formerly listed, later privatised) PRC-based metals company.
- A U.S.-based fund had received information to suggest that there may be some issues associated with its investment portfolio in Japan. It was also concerned that details of several investments had not been disclosed by its former representative in the country. We were engaged to gain an understanding of the issues that could be used to back its decision-making regarding the future of its investments in the country and provide useful leverage for discussions with former representatives and/or evidence for any subsequent legal proceedings against third parties. We undertook an analysis of relevant documentation found at the client's office in Japan, and combined this with discreet external inquiries to identify any information to suggest that the former representative or others mismanaged the portfolio or failed to disclose important information. In addition, we conducted data forensic imaging and analysis of office computers to locate any indication of fraudulent activity. Our investigation revealed that the former representative and his associates had set up a number of Special Purpose Companies without the knowledge of our client's management. At the same time, the client's name was used by some of these Special Purpose Companies to make investments, even though the funds appeared to have come from the former representative without the client's approval. We subsequently supported several civil and criminal actions taken against those involved.
